

REGULAR MEETING

LOUDON CITY COUNCIL

December 20, 2010

The regular meeting of the Loudon City Council was held on December 20, 2010 in the Council Meeting Room. The meeting was called to order at 7:30 P.M. Those present were: Mayor Judy Keller, Council members Mike Cartwright, Judy Jones, Lynn Millsaps and Jimmy Parks. Also present were City Attorney Edwin Arnold, City Manager Lynn Mills and City Recorder Stephanie Putkonen. The press was represented by Vicky Newman of the *News Herald*. Stephanie Smallen videotaped the meeting for LCTV3. There were three citizens present.

Attorney Arnold held the invocation. Councilmember Cartwright led the Pledge of Allegiance to the Flag of the United States of America.

Mayor Keller asked if council members had a chance to review the minutes of the regular meeting held on November 15, 2010. **A motion was made by Councilmember Cartwright, seconded by Councilmember Millsaps and unanimously passed to approve as written the minutes of the regular meeting held on November 15, 2010.**

Council considered the administrative approval of the purchase of gasoline and diesel fuel (\$2.4568 per gallon for unleaded plus gasoline and \$2.5194 per gallon for diesel fuel) on December 10, 2010 from the low bidder Pilot Travel Centers LLC. **A motion was made by Councilmember Millsaps, seconded by Councilmember Cartwright and unanimously passed to administratively approve the purchase of gasoline and diesel fuel (\$2.4568 per gallon for unleaded plus gasoline and \$2.5194 per gallon for diesel fuel) on December 10, 2010 from Pilot Travel Centers LLC.**

Council considered the award of a bid for basketball, baseball and softball uniforms. Bids were received from Team Sports Outfitters (\$8,962.50) and Innovative Designs (\$9,637.50). **A motion was made by Councilmember Parks seconded by Councilmember Millsaps and unanimously passed to approve the bid for basketball, baseball and softball uniforms to the low bidder, Team Sports Outfitters, for \$8,962.50.**

Mayor Keller recognized the visitors and asked if anyone had anything to bring before council that did not appear on the agenda. There was no response.

Mayor Keller presented for final reading an ordinance to amend the zoning map by rezoning approximately 1.46 acres located at 8195 River Road from R-1-S to C-4. A motion was made by Councilmember Millsaps, seconded by Councilmember Cartwright that the following ordinance be passed:

ORDINANCE NO. 2010-15

AMENDING THE ZONING MAP OF THE CITY OF LOUDON, TENNESSEE, PURSUANT TO §13-7-203 AND §13-7-204 OF THE TENNESSEE CODE ANNOTATED, TO REZONE APPROXIMATELY 1.46 ACRES LOCATED AT 8195 RIVER ROAD, REFERENCED BY: TAX MAP 40, PARCEL 7:00; FROM R-1-S (SINGLE FAMILY RESIDENTIAL DISTRICT) TO C-4 (INTERCHANGE COMMERCIAL DISTRICT)

Upon a vote the AYES were: Millsaps, Cartwright, Jones, Parks and Keller. There were no NAY votes. Mayor Keller declared the ordinance passed on second and final reading.

Council considered the final reading of an ordinance prohibiting parking on the southeast side of Williamson Drive in Blair Bend Industrial Park. A motion was made by Councilmember Cartwright, seconded by Councilmember Parks that the following ordinance be passed:

**PROHIBITING PARKING ON THE SOUTHEAST SIDE OF
WILLIAMSON DRIVE**

Upon a vote the AYES were Cartwright, Parks, Jones, Millsaps and Keller. There were no NAY votes. Mayor Keller declared the ordinance passed on second and final reading.
